Our first stop will be a guided tour of the Cathedral Basilica. This is a one-of-a-kind work of art! With its lofty vaults and radiant Mosaics, the sheer scale of beauty is a thing of awe. Visiting the museum and touring the Cathedral Basilica with our guide proves to be breathtaking as we learn the symbolism and its rich history.

Lunch at Tucker's Place will be Salad, 10 oz Sirloin Steak, Baked Potato, Rolls, Beverage and Turtle Cheesecake for dessert.

Our next stop will be at the Shrine of St. Joseph. This church began in 1843 with Jesuits founding to serve the German immigrants. The Church is the only site of an authenticated miracle in the midwestern USA.

Christ Church Cathedral will be our next stop. This Episcopal Cathedral for the Diocese of Missouri was built in 1868. Designed by Leopold Eidlitz of New York is an example of 14th Century early English Gothic and is cruciform (Cross shaped) in design. It is renowned for its stained glass windows, but its crowning glory is its Reredos, elegantly sculpted wall 35 feet tall behind the altar.

We will return to Valley Park around 4:45 p.m. and St. Clair around 5:15 p.m.
